Cycle 2304 and 2305

RWY 11/29 declared distances and THR positions incorrect

Jeppesen Airport Moving Map and A816 formatted data for cycle 2304 (effective 20 April 2023) and cycle 2305 (effective 18 May 2023) contain incorrect data for Hato Intl; Willemstad, Netherlands Antilles (TNCC). Dutch Caribbean AIP SUP 13/23, effective 25 April 2023 (replacing AIP SUP 11/23, effective 20 March 2023), introduced temporary changes to RWY 11/29 declared distances, due to construction work in RESA of RWY 11 and RESA of RWY 29. Construction will be conducted in two phases. The following changes are not reflected in the data:

Phase 1 and 2 (effective from 25th of April 2023 till 5th of June 2023 and from 6th of June 2023 till 17th of July 2023):

Temporary Threshold RWY 29 Coordinates: 12° 11' 10.493 N, 68° 56' 49.293 W

Temporary Threshold RWY 29 End Coordinates: 12° 11' 29.686 N, 68° 58' 20.318 W

Temporary Threshold RWY 11 End Coordinates: 12° 11' 10.493 N, 68° 56' 49.293 W

Note: There are no changes to the Displaced Threshold RWY 11.
