Hato Intl (TNCC) Cycle 2306

RWY 11/29 declared distances and THR positions incorrect

Jeppesen Airport Moving Map and A816 formatted data for cycle 2306, effective 15 June 2023, contain incorrect data for Hato Intl; Willemstad, Netherlands Antilles (TNCC). Dutch Caribbean AIP SUP 17/23, effective 07 June 2023 (replacing AIP SUP 13/23, effective 25 April 2023), introduced temporary changes to RWY 11/29 declared distances, due to construction work in RESA of RWY 11 and RESA of RWY 29. Construction is being conducted in two phases. Due to prolongation of Phase 1, the following changes are not reflected in the data.
